Prof. Nunes holds a Ph.D. in Law in Brazil. In the United States, she is a Visiting Fellow at Yale University, and, in Europe, she also is "Investigador" at GIESA-BIOLAW Research Group on Universidad Complutense de Madrid.

In Brazil, Dr. Nunes is an Invited Professor at the UFAM Graduate Program, an External Reviewer of Research Projects, and an "ad hoc" reviewer of several scientific journals and scientific-legal publishers.

In the United States, she received the 2019 Emerging Scholar Award on Climate Change and in 2018, Dr. Nunes received one of the most prestigious honors, the Sergio Vieira de Mello Medal, as an Ambassador of Culture, Peace, and Justice in the World, by the International Council of Honors.

The author's collection was a remarkable research in 2018-2019. The chapters were produced during Prof. Nunes research appointment at the Council onLatin American and Iberian Studies (CLAIS). At Yale Uni-versity, CLAIS serves as the central hub for intellectual ex-change and collaborations in Latin America, Spain, and Portugal. CLAIS promotes linkages with the other U.S., Latin American, and Iberian institutions to bolster cooperation and understanding of these interconnected regions. The author brings four papers of her period at CLAIS.

The first chapter deals with the history of the territorial dispute between Bolivia and Chile. She chose two works on Environment Law. Both are Amazon Rainforest issues. The first reviews the government regulation of biotechnology and the second examines Brazil's difficulty in developing Bioeco-nomics for the country's progress.

Finally, she presents a work with two authors (Pedro Diaz Peralta and Fernando Gonzalez Botija), entitled Chal-lenges of the alignment of Brazil to Council of Europe (CoE) Santiago de Compostela's Convention on Trafficking in Hu-man Organs, under a Comparative Public Law perspective (Brazil-EU) and related borderline.

The author is a prodigious researcher in the field of social sciences.
